
Greetings:

In summary, I was appointed to serve as a District Court judge in June of 1992 and have been named as Chief Judge of the 7th Judicial District in July of 2006. I have earned a bachelor's degree in 1973 from the University of Dubuque; a master's degree in 1975 from the University of Iowa; and a law degree from the University of Iowa in 1983. After graduation from law school I was a law clerk for the judges of the Seventh Judicial District; I was an assistant Scott County attorney; and I practiced law as a sole practitioner. From 1987 until my appointment as a judge in 1992 I was a part-time magistrate in Scott County. I am a member of the Scott County and Iowa State Bar Associations, as well as the Iowa Judges Association, National Association for Women Judges, American Judicature Society, and the National Council of Juvenile and Family Court Judges.
